# Road Infrastructure and Socio-Economic Development in Akwa Ibom State, Nigeria

## **ABSTRACT**

Despite significant investments by the Akwa Ibom State government in road infrastructure, the state continues to face developmental challenges. Poor road conditions have hampered economic activities, access to education, healthcare service delivery, and limiting the state's potential for comprehensive socioeconomic growth. This study assessed the nexus between road infrastructure and socio-economic development in Akwa Ibom State using a survey research design. Data were collected through questionnaires using stratified random sample from Akwa Ibom State's population of 7.2 million. The study established significant positive association between road infrastructure and agricultural, access to education, and access to healthcare delivery services. Thus the good road infrastructure in the state supports the increased agricultural productivity, gave good access to educational facilities, and aided access to health care delivery services within the state. The study recommended that Akwa Ibom state government should prioritize road investments to boost market access and reduce transportation costs for farmers. Also, roads to schools should be rehabilitated to improve attendance and learning outcomes' and rural roads should be upgraded to enhance healthcare access. Addressing these problems will significantly improve Akwa Ibom's socioeconomic development.

#### INTRODUCTION

In Nigeria, road infrastructure is a vital component of national development, comprising transportation, communication, utilities, and more. However, the country's network is plagued bv maintenance, low finance, and faulty construction, leading to severe deterioration. (1993),According to Kessides infrastructures are crucial for connecting diverse sectors of the economy and boosting the quality of life. However, in Nigeria, the road network is plagued by poor maintenance, low finance, and faulty construction, leading to severe deterioration (Onolememen, 2012). This leads in higher increased traffic transportation costs, accidents, impeded economic and operations. Good road infrastructure considerably benefits the economy by decreasing transportation costs, promoting corporate efficiency, and expanding access to markets (Ogunsanya, 2022). It also increases educational outcomes by ensuring that kids and staff can travel securely to positively impacts schools. which achievement. attendance and academic Similarly, good roadways enable rapid access to medical facilities, which is crucial for both emergency responses and normal delivery (Eguniobi, healthcare 2004). Conversely, bad road conditions enhance vehicle operating costs and travel times; leading to higher consumer prices and diminished corporate competitiveness. Poor road infrastructure also adds to road traffic accidents, resulting loss of lives and additional pressures on the healthcare In locations. system. remote these shortcomings can increase poverty by limiting access to important services (Akinyemi, 2013).

Nigeria's road infrastructure is characterized by severe defects, with many roads in poor condition due to inadequate

design and funding (Onolememen, 2012). In Akwa Ibom State, these difficulties are visible, with roads deteriorating rapidly due to the absence of a coordinated maintenance strategy. This condition limits economic operations and access to social services, impacting the general quality of life in the state. The impact of good road infrastructure on socioeconomic development is profound, as it facilitates efficient movement, boosts productivity, attracts investments, creates jobs, reduces poverty, and promotes social inclusion by improving access to education and healthcare, reducing disparities between urban and rural areas (Aderamo & Magaji, 2010). Several causes contribute to the poor state of Nigeria's road infrastructure, including inadequate financing, corruption, bad maintenance culture, and technical errors in construction. Inadequate funding to delayed or abandoned road leads construction, while corruption results in inadequate work and inflated expenses. The regular maintenance further lack of accelerates road deterioration, and technical inadequacies in construction procedures result in roads that are not durable (Odeleye, 2000). To address these difficulties, the Nigerian government has enacted policy reforms, boosted budget allocations, and public-private partnerships promoted targeted at improving road infrastructure. Public-private partnerships have essential in bridging financial gaps and using private sector knowledge to improve road construction and maintenance.

The deteriorating road infrastructure in Akwa Ibom State has become a significant barrier to the region's socioeconomic development. Poor road conditions have consistently hindered the efficient movement of goods and people, leading to higher transportation costs, frequent delays, and reduced productivity. These challenges have disproportionately affected businesses, particularly small and

medium-sized enterprises, by driving up operational costs and limiting access to markets. In addition to economic consequences, inadequate road infrastructure severely affected education healthcare. In rural areas, students and teachers face hazardous and lengthy commutes to schools, leading to lower attendance rates, chronic punctuality issues, and declining academic performance. This has widened the educational gap between urban and rural communities, exacerbating disparities in resources and outcomes. Despite the recognition of the critical role road infrastructure plays in economic development, the specific impact on the socioeconomic development of Akwa Ibom State has been inadequately addressed. This situation underscores the urgent need for targeted policy interventions to improve road infrastructure and enhance the overall development of the region.

The specific objectives of this study were to examine the influence of road infrastructure on agricultural productivity in Akwa Ibom State; ascertain the relationship between road infrastructure and access to education in Akwa Ibom State; and determine the influence of road infrastructure on healthcare service delivery in Akwa Ibom State.

#### CONCEPTUAL CLARIFICATION

The history of road infrastructure may be traced back to ancient civilizations, where roadways were initially created for military and trade objectives. The Roman Empire is notably renowned for its large network of highways, which allowed for the efficient movement of troops and supplies across its territory. Roman roads were recognised for their durability, frequently containing many layers of materials like gravel and stones to provide stability and lifespan (Chevallier, 1976). The Industrial

Revolution in the 18th and 19th centuries heralded a transformative phase for road development, infrastructure with construction of turnpike roads, funded through tolls, becoming widespread in Britain and other parts of Europe. The highways, constructed to superior standards, diminished trip durations and transportation expenses, considerably enhancing economic efficiency. The National Road, constructed in the early 19th century in the United States, was among the initial extensive government-funded road initiatives. promoting expansion westward economic development by offering a dependable passage across the Appalachian Mountains (Searight, 1894). The 20th century saw significant improvements in road infrastructure, propelled by emergence of the vehicle and urbanisation.

The necessity for improved roads to support motor vehicles prompted numerous governments to initiate extensive road construction initiatives (Pawson, 1977). The U.S. Interstate Highway System, established in the 1950s under President Dwight D. Eisenhower, is a significant achievement of this period. Similarly, Germany's autobahn network created new norms in road emphasizing construction, high-speed capabilities and engineering quality. The expansion of road networks extended beyond industrialised nations; numerous developing countries, particularly in Africa, Asia, and Latin America, commenced investments in road infrastructure as a component of their development goals (Blanton, 1936). In emerging nations, road infrastructure has been essential to national growth, especially in post-colonial countries. For instance, Nigeria's focus on extending its road network since independence in 1960 has been vital for boosting connectivity and stimulating economic growth. Significant initiatives, such the Lagos-Ibadan Motorway

East-West Road. enhanced and the connectivity to major centres and industrial areas. However, the viability of Nigeria's road infrastructure has often undermined by inadequate maintenance, corruption, and insufficient funding (Onolememen, 2012).

The 21st century has introduced novel difficulties and prospects in road infrastructure development. urbanization and technology improvements have transformed how countries handle road building and maintenance. One notable trend is the incorporation of smart technology, such as Intelligent Transportation Systems (ITS), which integrates digital technologies to optimise traffic flow, road safety, and efficiency (Ghosh & Lee, 2000). Another major breakthrough is the use of sustainable materials in road construction. Eco-friendly such recycled asphalt solutions, and pavements, mitigate permeable the environmental impact of road infrastructure while improving durability and resilience (Hansen, 2009). Public-private partnerships (PPPs) are essential for financing road infrastructure projects, bridging funding deficits and accelerating the implementation of crucial road networks (Federal Ministry of Works, 2013).

## **Socioeconomic Development**

Socioeconomic development refers to the process of improving the economic. social, and environmental well-being of individuals and communities. It aims to enhance living standards, reduce poverty, and achieve sustainable progress across multiple dimensions (United Nations, 2020). According Todaro to and Smith (2015)Socioeconomic development drives growth by increasing productivity, fostering innovation, and attracting investments, generating employment, raising incomes, reducing and poverty. Sustainable socioeconomic initiatives mitigate ecological degradation and promote conservation efforts, while politically, it strengthens governance and stability by reducing social tensions and promoting equitable policies (Sen, 1999). On a global scale, nations engaging in socioeconomic development contribute to international stability by participating in trade, sharing knowledge, and working toward collective goals such as the Sustainable Development Goals (World Bank, 2020).

Socioeconomic development is a critical aspect of economic growth, but it also faces numerous challenges. These include persistent economic inequalities, marginalized groups, youth unemployment, underemployment, environmental degradation, social exclusion, weak governance structures, infrastructure deficits, and global economic uncertainties. To address these issues, it is essential to build resilience through diversified economies adaptive strategies and (UNESCO, 2020; WHO, 2020).

Measuring socioeconomic development requires a range of indicators capture economic. social. environmental progress. Economic measures such as GDP and per capita income provide insights into a nation's prosperity and growth trajectory. Educational outcomes are assessed through metrics like literacy rates, school enrollment ratios, and levels of educational attainment. Healthcare accessibility is measured through indicators such as life expectancy, immunization rates, and maternal mortality (UNEP, 2020). Environmental sustainability is evaluated through indicators like carbon emissions, access to clean water, and biodiversity conservation (World Bank, 2020). Social inclusion and equity are captured by measures of gender equality, access to basic services, and participation in decision-Governance making. and institutional quality are assessed through indicators of transparency, accountability, and the rule of law (UNDP, 2020).

# **Agricultural Productivity**

Agricultural productivity plays a crucial role in socioeconomic progress, contributing significantly to food security, economic growth, job creation, and poverty reduction. It involves improving agricultural practices, technologies, and structures to enhance productivity, sustainability, and profitability. For countries like Nigeria, where agriculture forms the backbone of the agricultural economy. productivity essential for economic diversification (FAO, 2020). This includes activities such as crop cultivation, animal husbandry, and the commercialization of agricultural products, all of which support rural livelihoods and drive national economic growth (World Bank, 2021).

Livestock farming, or livestock farming, is a vital component of agricultural productivity. In Nigeria, staple crops like maize, cassava, rice, and yam are essential for sustenance and form the backbone of local diets (Nwafor et al., 2021). Cash crops like cocoa, oil palm, and rubber contribute to foreign exchange earnings, supporting economic growth. The commerce of agricultural products bridges the gap between production and consumption, facilitating the distribution of (Akinola & Adeniran, 2020).

However, agricultural productivity faces significant challenges: limited access to modern farming technologies, poor infrastructure, and inadequate financing hinder productivity and growth. Many livestock farmers still rely on traditional methods, which limit productivity and increase vulnerability to diseases. Similarly, crop farmers often lack access to improved seeds, fertilizers, and irrigation systems, leading to low yields and food insecurity. The commercialization of agricultural

products is also constrained by poor road networks, inadequate storage, and weak market linkages, resulting in post-harvest losses and reduced profitability (Adesina & Salau, 2021).

Agricultural productivity is crucial for overcoming these challenges. Integrated farming systems, combining crop and livestock production, enhance resource efficiency and reduce waste. Promoting organic farming and agro-forestry can conserve soil fertility, protect biodiversity, and mitigate climate change impacts. Supporting smallholder farmers through cooperative farming, microcredit, and capacity-building programs is vital for achieving sustainability and inclusivity (Eze et al., 2020).

Government policies, such Nigeria's Agricultural Transformation Agenda (ATA) and the Anchor Borrowers' Program (ABP), have been pivotal in addressing these challenges. The ATA focuses on increasing the production of staple crops, reducing post-harvest losses, and promoting agro-industrial development, while the ABP provides credit facilities to buy inputs and expand operations. With continued government support, private sector involvement, and international partnerships, these initiatives have the potential significantly enhance agricultural productivity in Nigeria (Nwafor et al., 2021).

#### Access to Education

Access to education is a critical aspect of individual and societal development, with implications economic progress, innovation, and social mobility, especially in developing countries like Nigeria. However, various challenges equitable access advanced to education, hindering its potential to drive socioeconomic progress (Okebukola, 2021).

Inadequate infrastructure is a major challenge in Nigeria, with many public universities and colleges facing shortages of lecture halls, libraries, laboratories, and accommodation facilities. This leads to overcrowded classrooms and outdated facilities, compromising the quality of education. Substantial investments in physical and digital infrastructure are needed to address these limitations and improve access to education (Oyetunji & Uche, 2022).

Financial barriers also pose significant obstacles, making education unaffordable for many low-income families. Expanding scholarship programs and developing sustainable funding mechanisms would alleviate the financial burden on students and their families, improving access education. Geographical advanced disparities further exacerbate inequalities in access to education, with urban areas generally having better access to educational resources and opportunities, while rural lack adequate primary and regions secondary education to prepare students for higher learning (Adamu, 2023).

Geographical disparities further exacerbate inequalities in access to education. Urban areas generally have better educational resources to opportunities, while rural regions lack adequate primary and secondary education to prepare students for higher learning. This urban-rural divide limits opportunities for rural students, restricting their ability to pursue advanced education. Establishing more institutions in underserved areas and offering preparatory programs could help bridge this gap and promote inclusivity (Afolabi et al., 2023).

Limited capacity of institutions creates a bottleneck in access to higher education, with the number of qualified candidates often exceeding available spaces, leading to brain drain and many students seeking education abroad. Promoting gender-sensitive policies, offering scholarships for female students, and raising awareness about the importance of educating women are essential steps to addressing this disparity (Okebukola, 2021).

Frequent disruptions to the academic calendar, such as strikes by academic staff unions and political instability, also impede access to education in Nigeria. Ensuring stability in the academic calendar through collaborative efforts between governments and educational stakeholders is crucial for improving access and outcomes. To enhance access to education, governments and stakeholders must prioritize policies that address challenges. these **Expanding** financial leveraging aid programs, technology to promote online and distance learning, and curriculum reforms professional development ongoing educators will ensure that the education system meets the needs of modern society (Oyetunji & Uche, 2022).

# **Heath Care Service Delivery**

Healthcare accessibility refers to the ability of individuals and communities to obtain healthcare services that meet their needs without being hindered by financial challenges, geographical barriers, inadequate healthcare resources. In many sub-Saharan African countries, including Nigeria, inadequate healthcare infrastructure presents a significant challenge. Healthcare services are predominantly concentrated in urban areas, leaving rural and remote communities underserved. Expanding healthcare infrastructure to rural underserved areas is critical to improving access and equity (WHO, 2020).

Financial barriers significantly impact healthcare accessibility, with financing predominantly out-of-pocket, making it unaffordable for many low-income households. The urgent need for

universal health coverage (UHC) systems to provide financial protection and ensure access to essential healthcare services without undue hardship is essential for reducing reliance on out-of-pocket payments and increasing equitable healthcare access. This financial strain is worsened by limited health insurance coverage in the country (Bloom et al., 2018).

The shortage of healthcare professionals further exacerbates challenges in accessing quality healthcare, especially in developing countries. Strengthening the healthcare workforce through enhanced training, competitive compensation, and environments is supportive working essential to addressing this challenge. Oladipo (2021) highlighted that retaining healthcare professionals within Nigeria is a key step toward achieving a robust and accessible healthcare system. Healthcare accessibility in Nigeria is influenced by various cultural and social factors, including traditional beliefs, stigma, discrimination. Public awareness campaigns and community engagement are crucial in addressing these barriers, as they educate communities about the importance of healthcare. dispel myths surrounding modern medicine, and reduce stigma associated with specific health conditions.

Cultural and social factors also influence healthcare accessibility. In many Nigerian communities, cultural beliefs and practices affect healthcare-seeking behaviors. Some individuals traditional medicine over modern healthcare services, believing it to be more effective or culturally appropriate. Furthermore, stigma and discrimination associated with certain health conditions, such as HIV/AIDS or mental illnesses, deter individuals from seeking care. Adeloye et al. (2022) pointed out that public awareness campaigns and community engagement are crucial in addressing these cultural barriers. Such

initiatives can educate communities about the importance of healthcare, dispel myths surrounding modern medicine, and reduce stigma associated with specific health conditions.

Policy reforms and targeted interventions play a critical role in improving healthcare accessibility. Governments have increasingly recognized the need for robust strategies to expand healthcare financing and improve service delivery. Strengthening the National Health Insurance Scheme (NHIS) and other healthcare financing models can improve especially access to healthcare. underserved populations. Additionally, increasing investments in healthcare systems and infrastructure is crucial for achieving equitable distribution of resources and services (WHO, 2020).

Technological advancements offer immense potential to overcome barriers to healthcare accessibility. Telemedicine enables patients in remote areas to consult healthcare providers without the need to travel long distances, while mobile health applications and digital platforms can provide health education, facilitate appointment scheduling, and support disease management. The integration of digital solutions into Nigeria's healthcare system could revolutionize access, especially in rural areas where physical healthcare facilities are sparse (Bloom et al., 2018)

Partnerships between the public and private sectors, as well as collaboration with civil society organizations, are essential for achieving sustainable improvements in healthcare accessibility. These partnerships mobilize resources, drive innovation, and strengthen healthcare delivery systems. Integrated health systems that combine public and private sector efforts are more efficient and can reach underserved populations effectively (WHO, 2020).

#### THEORETICAL FRAMEWORK

# **Infrastructure-led Growth Theory**

The infrastructure-led growth theory, advanced by scholars such as Aschauer (1989) and Calderón and Servén (2004), underscores the essential role infrastructure investments, particularly in transportation, play in driving economic growth and development. The theory is centered on the idea that improving infrastructure—such as road networks—can enhance productivity, reduce transaction costs, and foster economic activity across various sectors. Aschauer (1989) highlighted government investment infrastructure, especially public capital, has a direct impact on national economic performance. He argued that infrastructure improvement leads to increased productivity by reducing operational costs and improving market access for businesses. Calderón and Servén (2004) extended this view, asserting that investments in infrastructure promote economic growth by facilitating trade, improving connectivity, and creating a more efficient economic environment. According to them, infrastructure reduces logistical constraints and boosts the movement of goods, services, and people, fostering regional international and economic integration.

The relevance of the Infrastructureled Growth Theory to the study of road infrastructure and socio-economic development in Akwa Ibom State, Nigeria, like many evident. Akwa Ibom, developing regions, faces significant challenges in infrastructure development, particularly of in the area road transportation. Improving road infrastructure in the state is expected to transportation costs, improve market access, and enhance overall economic efficiency, all of which are central tenets of the Infrastructure-led Growth Theory.

example, better road networks will enable local businesses to reduce logistical costs, facilitating easier access to both local and international markets. This could particularly beneficial for industries such as agriculture and manufacturing, which are heavily dependent efficient on transportation. Improved connectivity between urban and rural areas can also foster more inclusive development by enhancing access to essential services such as healthcare and education, promoting a higher quality of life, and reducing poverty.

of road infrastructure on economic development in Nigeria. The study focused the relationship between road infrastructure, economic activities. employment, and regional development. Using a mixed-methods approach, it combined surveys and interviews with stakeholders. The study found that better road infrastructure boosted trade, reduced transportation costs, and increased market accessibility, leading to higher employment and economic growth. The recommended increased investment in road infrastructure and maintenance. community involvement in planning to address regional disparities.

Adebayo and Alabi (2022) examined the impact of road infrastructure on socioeconomic development in Lagos State. focused employment The study on generation, poverty reduction, agricultural productivity. It used a mixedmethods approach, combining quantitative surveys with qualitative interviews. The findings showed that improved road impacted infrastructure positively reduced employment, poverty, supported the growth of SMEs. The study recommended continuous investment in infrastructure, inclusive urban planning, and

policies to support SMEs and entrepreneurship.

Aderamo Magaji and (2021)assessed the impact of road infrastructure on economic development in rural Nigeria. They focused on agricultural production and trade. Using a mixed-methods approach, including surveys and interviews, they found that improved roads reduced transportation costs, facilitated market access, and attracted investment. Rural areas with better road networks saw higher incomes and improved living standards. The study recommended prioritizing rural road infrastructure, enhancing maintenance, and fostering public-private partnerships for sustainability.

Ibem and Amole (2023) explored the impact of road infrastructure on poverty alleviation in Ondo State, Nigeria. The study focused on the social and economic impacts of road infrastructure on rural communities. Using a mixed-methods approach, they found that improved roads contributed to increased agricultural productivity, reduced transportation costs, and enhanced access to social services. The study recommended sustained investment in infrastructure, along with targeted poverty alleviation programs to improve socioeconomic outcomes and reduce poverty levels.

Musonda and Chansa (2021) studied the impact of road infrastructure on health outcomes in Zambia. They focused on how road quality affects healthcare access and the distribution of medical supplies. Using a combination of surveys, GIS tools, and focus group discussions, the study found that better roads improved healthcare access, reduced emergency response times, and ensured timely medical supply delivery. The recommended prioritizing study road improvements in areas with limited healthcare access and integrating road infrastructure planning with health sector strategies.

Ogun (2010) examined the link between road infrastructure and poverty reduction in Nigerian urban areas, focusing on improved access to jobs, healthcare, and education. Using infrastructure-led growth and transportation cost theories, the mixedmethods study combined survevs. interviews. and econometric analysis. Findings showed that better roads reduced transportation costs and time, increasing income levels and lowering poverty rates. The study emphasized upgrading road networks to sustain these benefits and recommended prioritizing infrastructure investments. fostering public-private partnerships, and involving communities in planning for sustainable urban development.

Ogunsanya (2022) assessed economic effects of road infrastructure on Nigerian businesses, focusing on trade and logistics. Through surveys in cities like Lagos and Abuja, findings showed reduced transportation costs, faster deliveries, and increased profitability for businesses with improved road Enhanced access. connectivity also attracted foreign investments and stimulated local economies. Recommendations included sustained road development, public-private partnerships for maintenance, and streamlined transportation policies to maximize benefits for urban businesses and economic growth.

Olaseni and Alade (2022) explored challenges to achieving Vision 20:2020's infrastructure goals in Nigeria. Using a qualitative approach, the study highlighted corruption, inadequate funding, governance, weak institutional and frameworks as barriers to development. Recommendations included alternative financing like public-private partnerships, improved governance, stronger institutions, and better stakeholder collaboration. The study stressed aligning policy development implementation with

objectives to overcome challenges and drive Nigeria's infrastructural growth.

Olufemi (2020) investigated road infrastructure's impact urban development in Ibadan, Nigeria, focusing on land use, property values, and economic activities. Using spatial analysis qualitative data, findings revealed that better roads enhanced connectivity, increased property values, and spurred agricultural productivity. Recommendations included sustained infrastructure investment, equitable urban planning to manage growth, and policies to prevent congestion. The study emphasized balancing development with governance for inclusive urban progress.

#### METHODOLOGY

# **Research Design**

Survey research design, a quantitative method involving questionnaires or interviews, efficiently gathers data from a representative sample (Creswell, 2014). This study adopted this design to explore the impact of road infrastructure on socio-economic development in Akwa Ibom State, Nigeria.

#### **Population of the study**

The population of the study refers to the entire group of individuals or entities that a researcher is interested in examining (Creswell, 2014). In this study, the population consists of the estimated 7.2 million residents of Akwa Ibom State, Nigeria, as projected by the National Population Commission in 2022 (National Population Commission, 2022).

# **Sample Size Determination**

The sample size of the study is the proportion of individuals drawn from the population in order to examine the relationship between road infrastructure and socioeconomic development in Akwa Ibom State. The sample size for the study was determined at 5% level of significance using Taro Yameni's Formula.

## DATA PRESENTATION / ANALYSES

section This presents the demographic characteristics of respondents and the questionnaire responses aimed at achieving the study objectives. Out of the 400 copies of questionnaire administered, 343 were usable, while 57 were either not returned or incorrectly filled, representing a response rate of 85.75%. The high response rate provided reliable data to analyze the impact of road infrastructure on the socioeconomic development of Akwa Ibom The demographic characteristics State. covered aspects such as age, gender, educational background, and occupation to ensure that the sample represented a crosssection of the population affected by road infrastructure issues. This was followed by responses to questions directly related to the study's specific objectives, including how road infrastructure influences agricultural productivity, educational access, healthcare service delivery in Akwa Ibom State.

Table 1 analyzes the impact of road infrastructure on agricultural productivity in Akwa Ibom State, focusing on mean and standard deviation values. The mean values range between 2.64 and 2.68, indicating a general agreement among respondents about the positive impact of road infrastructure on various aspects of agricultural productivity. The small range suggests a consistent the closest consensus, while the highest perception across different dimensions examined. The highest mean value of 2.68

indicates a stronger agreement on importance of road infrastructure improving market access. The standard deviation values range between 1.10 and 1.13, indicating moderate variability in responses, possibly reflecting personal experiences or geographic location. The lowest standard deviation (1.10) indicates value (1.13) suggests slightly more diverse perspectives.

The study reveals a strong consensus significant impact of the on various infrastructure on aspects education in Akwa Ibom State, particularly in terms of accessibility, attendance, resource availability, and student retention (as captured in Table 2). The majority of respondents agreed that poor road conditions affect students' ability to reach schools, particularly in rural areas. Improved roads contribute directly to better school attendance, with a mean score of 3.75, indicating a high level of agreement. The

importance of road access in ensuring the availability of educational resources was also highlighted, with a mean score of 3.62, suggesting that other factors might also affect resource availability. Participants also agreed that road infrastructure plays a vital role in reducing student drop-out rates and facilitating access to higher education institutions, with mean values of 3.70 and 3.67, respectively, highlighting the critical role of roads in fostering academic continuity and educational opportunities.

The data in table 3 reveals strong agreement on the importance of road infrastructure in improving healthcare delivery in Akwa Ibom. The mean score for faster ambulance response times was 3.57, indicating that road conditions directly affect emergency medical responses. The mean score for reducing the time it takes for patients to reach healthcare facilities was 3.63, indicating that better roads reduce travel times to healthcare centers, a critical factor for timely treatment. The mean score for the accessibility of medical supplies was

3.57, indicating that good roads facilitate timely deliveries of essential medical goods. However, the mean score for increasing healthcare delays was 3.64, indicating that inadequate roads contribute to service interruptions. The high mean scores of 3.58 and 3.64 for facilitating access to a greater number of healthcare centers and positively affecting emergency healthcare services further emphasize the significant role of roads in broadening access to medical facilities and emergency care.

The correlation result in Table 4 indicates a positive relationship between road infrastructure and agricultural productivity in Akwa Ibom State, with a Pearson correlation coefficient of 0.615. Wahua and Fekadu (2025) support the use of correlation to measure association. This demonstrates that improved road infrastructure significantly enhances agricultural productivity in the region. Specifically, as the quality of road infrastructure improves, the efficiency and effectiveness of agricultural activities are greatly enhanced. The significance of this relationship (p = 0.002) confirms that good road conditions play a crucial role in boosting agricultural productivity in the state. Consequently, the null hypothesis (H0), which posited no significant relationship, is rejected, and the alternative hypothesis (Hi) is supported. These findings affirm that road infrastructure positively and significantly impacts agricultural productivity in Akwa Ibom State, emphasizing its importance in ensuring effective transportation of agricultural products and access to farming inputs.

# **Discussion of Findings**

The study done in Akwa Ibom State indicated a substantial positive link between road infrastructure and agricultural productivity and trade. The research suggests that enhanced road infrastructure positively influences corporate operations and trade efficiency, resulting to decreased operational costs, streamlined supply chains, and more efficient movement of goods and services. This has important consequences Akwa Ibom State's economic development, as it decreases transportation costs, improves timely product delivery, and gives greater market access, leading to

business expansion and improved tax revenues for the government. This study's findings align with those of Folarin et al. (2021) and Nwachukwu and Ogechukwu that road (2022),who also found infrastructure in Nigeria supports local growth, improves market business accessibility, and facilitates efficient distribution of goods.

The second hypothesis suggested that road infrastructure lacks a substantial correlation with access to educational facilities in Akwa Ibom State. However, the study indicated a positive connection with a Pearson value of 0.548 (p = 0.041), demonstrating enhanced road that infrastructure greatly boosts access to educational facilities for both students and teachers. Enhanced road conditions facilitate commuting to educational institutions. resulting in elevated school attendance and enhanced academic performance. This has enormous ramifications for the educational system in Akwa Ibom, particularly for kids in remote regions, which results in fewer improved absenteeism and academic achievement. These findings support the work of Nwosu et al. (2019) and Amadi and Ogbodo (2020), who highlighted that good road networks improve school enrollment rates and enhance educational access, particularly in rural Nigerian communities.

The third hypothesis examined the influence of road infrastructure on the provision of healthcare services in Akwa Ibom State. The results showed a positive association of 0.461 (p = 0.034), showing that enhanced road infrastructure promotes access to healthcare services. Properly maintained highways enhance prompt emergency medical assistance, guarantee effective movement of medical supplies, and minimise travel time for patients pursuing services. Efficient healthcare infrastructure is essential for guaranteeing prompt access to healthcare facilities, especially during emergencies. These findings are consistent with those of Ajibade et al. (2020), who noted that inadequate road infrastructure in rural areas worsens health outcomes and limits access to healthcare.

#### Conclusion

The study reveals that road infrastructure crucial for is the socioeconomic development of Akwa Ibom State, influencing key sectors like business operations, education, and healthcare delivery. Maintaining well-maintained roads transportation reduces costs. efficient supply chains, and expands market access, promoting economic growth. Good roads also improve access to schools, boost academic performance, and enable timely emergency responses and efficient delivery findings medical supplies. These of importance of road underscore the infrastructure in fostering sustainable development and improving quality of life in the state.

## Recommendations

Based on the findings, the following recommendations were made:

- That the Akwa Ibom State government should continue to improving road invest in infrastructure to enhance access to agricultural markets and services, boosting agricultural productivity and supporting rural development.
- ii. That the Akwa **Ibom** State government should prioritize upgrading road networks leading to educational institutions, ensuring reliable transportation for students and teachers, thereby increasing access to education and improving academic outcomes.

iii. That the Akwa Ibom State government should focus on maintaining and improving access roads healthcare facilities, particularly in rural areas, to ensure timely medical care and strengthen overall healthcare delivery.
